Study on the Implementation of the 2005 UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions for the European Parliament

BACKGROUND INFORMATION

Introduction

The Geneva based law firm Germann Avocats and its interdisciplinary research team is completing a study for the European Parliament's Committee on Culture and Education (CULT) whose overall objective is to provide a summary of the state of implementation of the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions of 2005, in particular in fields where the European Community would be expected to provide leadership or coordination.

This study shall give assistance and long-term guidance to the EU on implementing the UNESCO Convention by carrying out a detailed analysis of the obligations set out by this international treaty. In particular, we shall gather information on the various practices in implementing the UNESCO Convention, from a legal and practical viewpoint, and identify challenges and measures to help achieve the objectives of this instrument.

For these purposes, we drafted three sets of questionnaires. The first questionnaire shall allow us to gather legal data. The second questionnaire shall inform us about the implementation of the UNESCO Convention from the perspective of representatives of civil society. The third questionnaire shall cover the situation from the angle of a selection of regional organizations. In addition, we shall interview representatives of international organizations that are relevant for the implementation of the UNESCO Convention (UNESCO, WTO and WIPO).

Expected results from the surveys

We expect to collect valuable information on public measures that are specifically undertaken to protect and promote cultural diversity on the national level in different jurisdictions. We shall obtain insights to compare regulatory practice in a variety of economic and political situations that characterize the selection of countries located in different geographical areas. We will obtain rich data that will allow us to compare regulatory practice in varying economic and political situations. We shall use and compare this information in our subsequent analysis that will eventually provide the basis of our conclusions and recommendations to the European Parliament.

Survey on regional organizations

This questionnaire will inform us about the existing and desirable implementation of the UNESCO Convention from the perspective of regional organizations. For this purpose, we invite the ASEAN, the African Union, the Association of Caribbean States, the Commonwealth, the International Organisation of Francophonie, the Council of Europe and the European Union to reply to our survey. The sample of regional organizations shall reflect geographical, economic and political diversity. The objective of this questionnaire is to clarify the perception and evaluation by representatives of regional organizations of the achievements of the UNESCO Convention in their respective territories. The main goal of this survey, beyond an inventory of the current legal and policy related situation, shall reside in exploring emerging best practices to implement the UNESCO Convention from the experience of the selected regional organizations.

The Foundation urges all other Commonwealth organisations to mainstream culture into their analyses and approaches.

PLEASE INSERT YOUR ANSWER HERE: Many Commonwealth Member States, particularly its smaller, developing states, have limited capacity for engagement with the Convention, as reflected in low levels of ratification and implementation. International co-ordination is poor and processes in Paris often seem to be dominated by voices of larger countries. There would seem to be a need for active development of government capacity and the active promotion of voices that can speak on behalf of smaller countries.

9 Which **major problems**, if any, related to the implementation of the UNESCO Convention does your organization identify so far?

PLEASE INSERT YOUR ANSWER HERE: The Convention is not well-articulated or explained as a development instrument. Levels of understanding of what the Convention is and what it stands for are very low. UNESCO has not given sufficiently priority of the promotion of the Convention. Little connection has been made to other issues of global social justice, and so the Convention has not won popular support and found itself the focus of advocacy for civil society beyond the cultural sector. The critique of the Convention as a potentially repressive tool – as a promoter of national majority cultures to the detriment of cultural diversity within national borders – has not adequately been addressed.
