# Study on the Implementation of the 2005 UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions for the European Parliament

#### **BACKGROUND INFORMATION**

# **Introduction**

The Geneva based law firm Germann Avocats and its interdisciplinary research team is completing a study for the European Parliament's Committee on Culture and Education (CULT) whose overall objective is to provide a summary of the state of implementation of the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions of 2005, in particular in fields where the European Community would be expected to provide leadership or coordination.

This study shall give assistance and long-term guidance to the EU on implementing the UNESCO Convention by carrying out a detailed analysis of the obligations set out by this international treaty. In particular, we shall gather information on the various practices in implementing the UNESCO Convention, from a legal and practical viewpoint, and identify challenges and measures to help achieve the objectives of this instrument.

For these purposes, we drafted three sets of questionnaires. The first questionnaire shall allow us to gather legal data. The second questionnaire shall inform us about the implementation of the UNESCO Convention from the perspective of representatives of civil society. The third questionnaire shall cover the situation from the angle of a selection of regional organizations. In addition, we shall interview representatives of international organizations that are relevant for the implementation of the UNESCO Convention (UNESCO, WTO and WIPO).

## **Expected results from the surveys**

We expect to collect valuable information on public measures that are specifically undertaken to protect and promote cultural diversity on the national level in different jurisdictions. We shall obtain insights to compare regulatory practice in a variety of economic and political situations that characterize the selection of countries located in different geographical areas. We will obtain rich data that will allow us to compare regulatory practice in varying economic and political situations. We shall use and compare this information in our subsequent analysis that will eventually provide the basis of our conclusions and recommendations to the European Parliament.

# Survey on regional organizations

This questionnaire will inform us about the existing and desirable implementation of the UNESCO Convention from the perspective of regional organizations. For this purpose, we invite the ASEAN, the African Union, the Association of Caribbean States, the Commonwealth, the International Organisation of Francophonie, the Council of Europe and the European Union to reply to our survey. The sample of regional organizations shall reflect geographical, economic and political diversity. The objective of this questionnaire is to clarify the perception and evaluation by representatives of regional organizations of the achievements of the UNESCO Convention in their respective territories. The main goal of this survey, beyond an inventory of the current legal and policy related situation, shall reside in exploring emerging best practices to implement the UNESCO Convention from the experience of the selected regional organizations.

PLEASE INSERT YOUR ANSWER HERE: While Trinidad and Tobago does not have regional law implementing the UNESCO Convention because Trinidad and Tobago has not ratified the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions, the Association of the Caribbean States as an International Regional Organization has a Draft Cooperation Agreement between the Association of Caribbean States and UNESCO for the promotion and preservation of the Diversity of Cultural Expression. The Agreement is at best a draft agreement and has not been ratified by the Member States of the ACS because of the fact that it was recognized that the objectives of the UNESCO Convention did not correlate to the functions and objectives of the ACS except in the area of linguistics or language learning.

PLEASE INSERT YOUR ANSWER HERE: Again the Association of Caribbean States has a Draft Cooperation Agreement existing between itself and the UNESCO which has not been ratified as yet by the Member States of the Association.

4.2 What **measures** in the sense of articles 6, 7 and 8 of the 2005 UNESCO Convention, including but not limited to measures aimed at protecting and promoting linguistic diversity, were adopted in your jurisdiction by the implementing regional law?

PLEASE INSERT YOUR ANSWER HERE: In Trinidad and Tobago under the University of the West Indies there exists a Centre for Languages and Language Learning, the Government through the Embassy of Venezuela has also encouraged the learning of Spanish as a second language in Trinidad and Tobago. There is also the Alliance Français which encourages the Learning of the French Language. Quite apart from the initiative of the government to encourage linguistic diversity, the Association of Caribbean States (ACS) as an International Regional Organization has also taken the initiative to promote the learning of the languages of the ACS English, Spanish and French. Under Agreement 12/07 of the 12<sup>th</sup> Ordinary Meeting of the Ministerial Council of the ACS, there is an Agreement Reaffirming support to establish the Centre for the Promotion of Language and Culture and to facilitate language learning

initiatives. In the recent Ministerial Council Meeting concluded in Cartegena of the Republic of Colombia Under Agreement 10/10 it was agreed that the Government of the Republic of Panama would host the Headquarters of the Centre for the Promotion of Languages and Culture of the Greater Caribbean (CPLC) following the signing of the Memorandum of Understanding between the ACS Secretariat and the Government of the Republic of Panama that was held on August 6<sup>th</sup> 2008.

4.3 How is article 11 of the 2005 UNESCO Convention ("participation of civil society") regulated in the implementing regional law?

PLEASE INSERT YOUR ANSWER HERE: The Government of the Republic of Trinidad and Tobago has not as yet ratified the UNESCO Convention however it has encouraged the members of civil society to show case aspects of the culture of Trinidad and Tobago by hosting various Cultural Shows, this is especially true during the Carnival Season since Carnival is a large income generator for the country and particularly for its citizens especially in the areas of costuming, the show casing of the musical talent of Soca and Calypso artistes and the national instrument of Trinidad and Tobago, the pan.

4.4 How are articles 20 and 21 of the 2005 UNESCO Convention ("relationship to other treaties" and "international consultation and coordination") regulated in the implementing regional law?

PLEASE INSERT YOUR ANSWER HERE: Again Trinidad and Tobago has not ratified the UNESCO convention and as such Articles 20 and 21 of the Convention would not be applicable to this jurisdiction, however the Association of Caribbean States (ACS) as an International Regional Organization did take steps to incorporate the terms of the Convention having regard to Articles 20-21 of the 2005 Convention by actually formulating a Draft Corporation Agreement between the ACS and the UNESCO, however again as indicated earlier on in this questionnaire, it was realized that the functions and objectives of the ACS and the UNESCO do not really correlate except for the promotion of linguistic diversity and as such the Agreement has remained a Draft Agreement at best, and it has not been signed or ratified by the various Member States of the ACS. Also the majority of States of the ACS have not ratified the Convention as yet and it is uncertain whether they intend to do so or not.

4.5 How does your organization assess and insure the compliance of its efforts to implement the UNESCO Convention with respect to its **human rights obligations**?

The ACS is really an organization which focuses on the key focal areas of trade, transport, tourism and natural disasters as opposed to that of promoting cultural expressions, nevertheless there has been some attempt to preserve linguistic

diversity and culture through the creation of the Centre for the Promotion of Languages and Culture of the Greater Caribbean.

## 18.1 Its strengths?

PLEASE INSERT YOUR ANSWER HERE: As a policy instrument, the Convention's strength lies in the fact that it seeks to promote an area which most of the developing states of the region of the Greater Caribbean can identify since they each share a common history, identity and heritage and preservation of that cultural identity is something with which most of the Caribbean states can easily identify since most of those states depend on their cultural expressions and diversity to generate their economic and social well being, particularly where most of those states are largely dependent on Tourism to generate their economy.

## 18.2 Its weaknesses?

This means that if the Convention is not ratified nor is it incorporated into national law, it is without any legal effect and therefore would be useless. In Trinidad and Tobago the Convention is yet to be ratified and incorporated into our legislation at the national level in order to have any legal effect or force. This is therefore a major impediment to implementing the objectives of the Convention and as such is a weakness of the Convention itself.

## 18.3 Its threats?
